### What is your top policy priority if elected?

# What steps would you take to increase transportation options for your constituents and how would you fund proposed projects or plans?

I plan to push for a study to explore the possibility of a county-run bus service that complements MARTA's existing network. While MARTA does a great job providing regional transit, a county-operated service could better connect local businesses, schools, and neighborhoods, improving access to jobs and essential services. This new system would enhance connectivity within DeKalb County, offering residents more convenient and efficient transportation options. Additionally, I'll continue advocating for MARTA's expansion in underserved areas like South DeKalb, working closely with state leaders and seeking out new funding sources to support these vital transportation improvements.

Expanding alternative transportation options is also a priority of mine. I will advocate for the expansion of trail networks throughout District 7, such as the South River Trail and Michelle Obama Trail, to provide both recreational opportunities and alternative commuting routes. These trails can serve as a cost-effective solution to transportation needs, particularly as the use of E-bikes grows. To fund these initiatives, I will push for the extension of the SPLOST tax and seek additional grants and federal funding to support both trail and broader infrastructure improvements.

# Housing costs in many parts of Georgia continue to rise. What should be done to keep housing affordable?

DeKalb County needs a well-rounded strategy to combat the rising cost of housing. One of the key steps we can take is to incentivize developers to include affordable housing in new projects, especially in areas where options are limited. Offering tax credits and financial incentives can encourage more developers to build affordable units. I also support reforming zoning restrictions that stand in the way of affordable housing development. It's time to rethink policies that block mixed-use developments and explore innovative housing solutions—like tiny homes or container homes—that can provide more affordable choices for residents.

As commissioner, I will also advocate for expanding homeownership programs that provide downpayment assistance to first-time buyers and repurposing vacant buildings for use as temporary shelters or affordable housing units. Addressing the housing crisis requires collaboration between city governments, developers, and the community. By creating a comprehensive strategy that tackles both the supply and accessibility of affordable housing, we can ensure long-term solutions that benefit everyone in DeKalb County.

# How do you plan to ensure that public funds allocated to your office are used efficiently and effectively?

Ensuring that public funds are used wisely and transparently is a top priority for me. With my experience managing multimillion-dollar budgets, I understand the importance of accountability when it comes to taxpayer money. If elected, I will introduce regular audits and make financial reports easily accessible to the public through online platforms. I also believe in involving the community in budgeting decisions by holding town halls and encouraging residents to share their input on how funds should be allocated. Transparency builds trust, and I'll make sure every dollar is spent to benefit the people of DeKalb County.

Additionally, I plan to advocate for the expansion of the county's open data portal, which will make it easier for residents to track how public funds are being spent. By ensuring that financial decisions are made with public input and are clearly communicated to residents, we can create a government that is more responsive to the needs of the community. I also plan to involve local residents in oversight committees to ensure community priorities are reflected in budgeting decisions.
