#### 1. Recognition and Acknowledgment

#### a. Identifying Issues:

How do you plan to identify and acknowledge the presence of environmental racism within Districts 3 and 7?

#### **Response:**

To identify and acknowledge the presence of environmental racism within DeKalb County, I will start by conducting a comprehensive environmental audit in collaboration with local organizations such as the South River Watershed Alliance (SRWA) and the Georgia Chapter of the Sierra Club. This audit will map out the areas most affected by pollution, landfills, and inadequate infrastructure, focusing on predominantly Black and low-income neighborhoods. I will also engage directly with community members through town hall meetings and listening sessions to document their experiences and concerns, ensuring that those most affected by environmental racism are heard and their issues are recognized at the county level.
